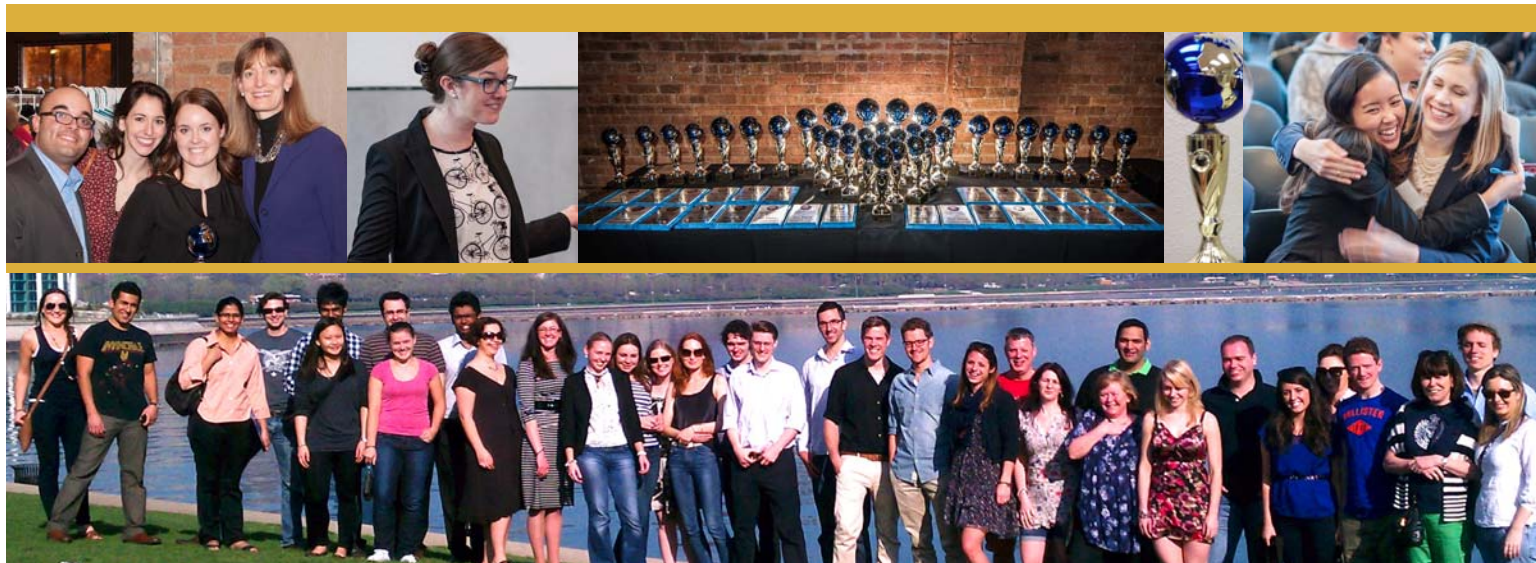

From the President



Dear Friends and Colleagues:

The InterNational Academy of Dispute Resolution (INADR) is asking you to sponsor one of its worldwide activities from international mediation competitions to its Annual World Congress. Since 2002, our goal is to introduce mediation worldwide to make the global community a better place in which to live. To this end, we have held mediation tournaments in areas where mediation is either unknown, or used rarely to resolve differences. Tournaments have been held in Dubai, United Arab Emirates, Bhopal, India, Kiev, Ukraine as well as Great Britain and the Irish Republic. Future tournaments will be held in Singapore, Brazil and Mexico. We have started a ripple effect which we hope will become a tsunami similar to the one that has touched the shores of America.

Building peace through mediation and the effects of our efforts cannot be underestimated. One Ukrainian student who was instrumental in organizing a 3-day training session and 2-day tournament in Kiev, Ukraine wrote:

It has been an honor for us to have the opportunity to arrange this event with the support of INADR. More than 50 students from Ukraine, Poland, Lithuania, Latvia, and Slovakia took part in the intensive 3-day training and the 2-day competition. The spirit of the tournament was full of motivation and friendliness. The students highly valued the knowledge they got and said they planned to use their skills in solving real cases; one student has made up her mind to specialize in the field of ADR. A lot of students are already planning their teams for next year's tournament and our foreign participants said they would love to have such an event in their law school.
